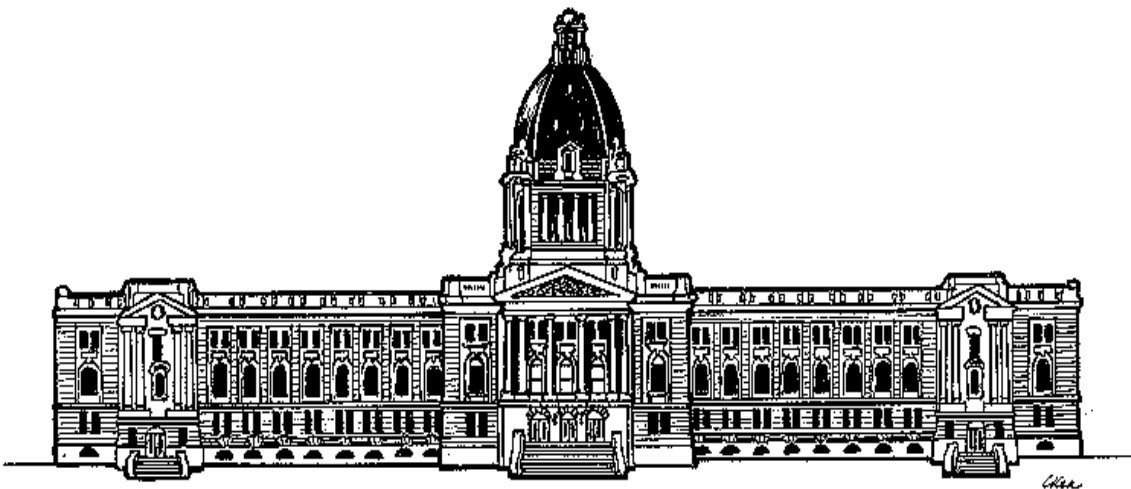

Mr. Park: — Good morning, committee members. Welcome to your Public Accounts Committee meeting today. Since your Chair, Mr. McCall, has resigned his position, it is my duty as Committee Clerk to preside over the election of a new Chair. I would like to remind members of the process. First I will ask for nominations. Once there are no further nominations, I will then ask a member to move the motion to have a committee member preside as Chair.

At this time, I will now call for nominations for the position of committee Chair. Mr. Cox.

Mr. Cox: — I would like to move that Danielle Chartier be elected to preside as Chair of the Standing Committee on Public Accounts.

Mr. Park: — Okay. Mr. Cox has nominated Ms. Chartier for the position of Chair. Are there any further nominations? Seeing none, I would now invite Mr. Cox to move that motion. Mr. Cox, can you move that?

Mr. Cox: — I so move.

Mr. Park: — All right. It has been moved by Mr. Cox that Ms. Chartier be elected to preside as Chair of the Standing Committee on Public Accounts. All in favour of the motion?

Some Hon. Members: — Agreed.

Mr. Park: — All opposed? I declare the motion carried and invite Ms. Chartier to take the Chair.

The Chair: — Thank you for that. I'm very happy to step into this role and looking forward to working with colleagues: my colleague from my side of the House, and from the government side, and looking forward to working with the staff.

So we have four documents to table here today. They are PAC 25/27, Standing Committee on Public Accounts; PAC 26/27, Ministry of Health; PAC 27/27, Ministry of Finance; PAC 28/27, Ministry of Agriculture.

As well I'd like to advise members that the following reports were deemed referred to the committee: Office of the Provincial Auditor annual report on operations for the year ended March 31st, 2013, on June 27th, 2013; Ministry of Finance, Public Accounts volume 1, on June 28th 2013; and Ministry of Finance, Public Accounts volume 2, on October 11th, 2013.

With that, if there is no other business, I'd like to ask for a motion to adjourn. So moved. The committee is adjourned.
