STANDING COMMITTEE ON PUBLIC ACCOUNTS May 17, 2022

[inaudible interjection] ... oh yeah, 2022. Lost a decade here. At the January 12th, 2022 meeting. PAC 55-29, Ministry of Justice and Attorney General: Responses to questions raised at the March 2nd, 2022 meeting; PAC 56-29, Provincial Auditor of Saskatchewan: Fourth quarter financial forecast for the year ending March 31st, 2022; PAC 57-29, Ministry of Finance: Report of public losses, January 1st, 2022 to March 31st, 2022; PAC 58-29, Ministry of Health: Report of public losses, January 1st, 2022 to March 31st, 2022; PAC 59-29, Ministry of Advanced Education: Report of public losses, January 1st, 2022 to March 31st, 2022. Thank everybody that endeavoured to get us the information that they said they would.

We'll now consider a motion with respect to attendance at the annual CCPAC/CCOLA [Canadian Council of Public Accounts Committees/Canadian Council of Legislative Auditors] conference in Ottawa, Ontario, August 28th to 30th, 2022. Of course for anyone interested, this is the annual conference of the public accounts committees, of Chairs and committee members from across Canada, as well as the auditors from across Canada in the respective provinces, territories, and the federal committee as well in the federal audit office.

That the Standing Committee on Public Accounts authorize the Chair, the Deputy Chair, one government member of the committee, and one opposition member of the committee to attend the Canadian Council of Public Accounts Committees and Canadian Council of Legislative Auditors annual conference to be held in Ottawa, Ontario from August 28th to 30th, 2022;

And further, that if the Chair or Deputy Chair or opposition member cannot attend, they be authorized to designate another committee member to attend in their place.

The Chair: — Moved by Deputy Chair Young, Lloydminster. All agreed?

The Chair: — That's carried. Okay, we'll move along to consider the second report of the twenty-ninth legislature. Of course this was shared by our committee Clerk. Thanks to Rob Park for his work and staff for compiling the report. Is there any discussion with respect to the report?
