That the Estimates as approved be forwarded to the Speaker as Chair of the Board of Internal Economy, pursuant to section 10.1(4) of *The Provincial Auditor Act*.

The question being put, the motion was agreed to.

The Chair advised the committee that an invitation had been received from the Chairman of the Australasian Council of Public Accounts Committees to attend the International Conference on Emerging Issues for Public Accounts Committees and similar type Committees early next year. A discussion ensued and it was moved by Mr. Harper:

That the Standing Committee on Public Accounts authorize the attendance of the Chair and Vice-chair at the International Conference on Emerging Issues for Public Accounts Committees and similar type Committees to be held in Melbourne, Australia, February 2<sup>nd</sup> to 5<sup>th</sup>, 2003;

And further, that if the Chair or Vice-chair cannot attend, they be authorized to designate another committee member to attend in their place.

The question being put, the motion was agreed to.
