2. The committee proceeded to consider Chapter 6 (Justice) of the 2003 Report of the Provincial Auditor (Volume 3). Mr. Mike Heffernan of the Office of the Provincial Auditor provided an overview of the chapter.

The committee concurred with recommendation 6-1 made at page 182 of Chapter 6 (Justice) of the *2003 Report of the Provincial Auditor (Volume 3)* that the Department of Justice should focus the work of its internal auditor on the processes and transactions where the Department is at greatest risk of loss of public money or spending money for unintended purposes. The committee noted that the Department of Justice is making progress towards complying with the recommendation.
- 4. The committee proceeded to consider Chapter 14 (Culture, Youth and Recreation) of the *2003 Report of the Provincial Auditor (Volume 3)*. Ms. Judy Ferguson of the Office of the Provincial Auditor provided an overview of the chapter.

The committee concurred with recommendation 14-1 made at page 286 of Chapter 14 (Culture, Youth and Recreation) of the *2003 Report of the Provincial Auditor (Volume 3)* that the Department of Culture, Youth and Recreation should document better its administrative policies and procedures to ensure it records transactions properly and promptly. The committee noted that the Department of Culture, Youth and Recreation is making progress towards complying with the recommendation.
- 6. The committee next considered its representation at the Canadian Council of Public Accounts Committees 25th Annual Conference. It was moved by Mr. Borgerson:

That the Standing Committee on Public Accounts authorize the attendance of the Chair, the Vice-Chair, one government member and one opposition member at the Twenty-fifth Annual Meeting of the Canadian Council of Public Accounts Committee to be held in Fredericton, New Brunswick, August 29th to 31st, 2004, and further that if the Chair or Vice-Chair cannot attend, they be authorized to designate another committee member to attend in their place.

The question being put, it was agreed.
