The committee noted that the Department of Environment is making progress towards complying with the recommendation.

The committee concurred with recommendation 10-2 made at page 146 of Chapter 10 (Environment) of the 2004 Report of the Provincial Auditor (Volume 1) that the Department of Environment should set sound and consistent terms and conditions for permits to regulate air emissions. The committee noted that the Department of Environment is making progress towards complying with the recommendation.
- 6. The committee concurred with recommendation 10-3 made at page 146 of Chapter 10 (Environment) of the 2004 Report of the Provincial Auditor (Volume 1) that the Department of Environment should establish processes to ensure permits to regulate air emissions are properly approved and expired permits are followed up promptly. The committee noted that the Department of Environment is making progress towards complying with the recommendation.
- 7. The committee concurred with recommendation 10-4 made at page 148 of Chapter 10 (Environment) of the 2004 Report of the Provincial Auditor (Volume 1) that the Department of Environment should set sound and consistent processes for monitoring compliance with permits to regulate air emissions and for handling air emission complaints. The committee noted that the Department of Environment is making progress towards complying with the recommendation.
- 8. The committee concurred with recommendation 10-5 made at page 149 of Chapter 10 (Environment) of the 2004 Report of the Provincial Auditor (Volume 1) that the Department of Environment should complete its human resource plan including a plan for employee training to regulate air emissions. The committee noted that the Department of Environment is making progress towards complying with the recommendation.
- 9. The committee concurred with recommendation 10-6 made at page 150 of Chapter 10 (Environment) of the 2004 Report of the Provincial Auditor (Volume 1) that the Department of Environment should establish systems to collect and maintain information to prepare reliable reports. The committee noted that the Department of Environment is making progress towards complying with the recommendation.
- 10. The committee concurred with recommendation 10-7 made at page 151 of Chapter 10 (Environment) of the 2004 Report of the Provincial Auditor (Volume 1) that the Department of Environment should improve its internal and external reporting on air emissions. The committee noted that the Department of Environment is making progress towards complying with the recommendation.
