The committee noted that the Saskatchewan Indian Gaming Authority Inc. is making progress towards complying with the recommendation.

And that the Public Accounts Committee recommend that the services of the Provincial Auditor and the Provincial Auditor's Office be made available to provide advice, if requested by the Federation of Saskatchewan Indian Nations (FSIN), to assist the FSIN with the establishment of an auditing institution, and that this offer be communicated to the FSIN.
