**PAC 34/25 – Investment Saskatchewan Inc.:** Correspondence from Eric Cline, Minister to Elwin Hermanson, Chair, re: Investment Saskatchewan's 2005 annual report and the inclusion of the Meadow Lake Pulp Limited Partnership in it, dated March 21, 2006.

That the letter from Liberal Leader David Karwacki, regarding his letter on auditing Meadow Lake Pulp mill be referred to the Standing Committee on Crown and Central Agencies for response, with a letter to Mr. Karwacki indicating the change.

The committee concurred with recommendation 3-1 made at page 89 of Chapter 3 (Learning) of the 2005 Report of the Provincial Auditor (Volume 3) that the Department Learning should use a department-wide risk assessment to guide the nature and extent of its evaluation activities. The committee noted that the Department of Learning is making progress towards complying with the recommendation.

The committee concurred with recommendation 3-2 made at page 90 of Chapter 3 (Learning) of the 2005 Report of the Provincial Auditor (Volume 3) that the Department Learning should provide staff with written guidance on situations unique to the Department to help staff avoid conflicts-of-interest. The committee noted that the Department of Learning is making progress towards complying with the recommendation.
- 7. The committee concurred with recommendation 3-1 made at page 91 of Chapter 3 (Learning) of the 2005 Report of the Provincial Auditor (Volume 3) that management of the Department Learning should review written support (including the method, assumptions, and source of key information used to determine the estimate) for all significant estimates prior to recording them in its financial records. The committee noted that the Department of Learning is making progress towards complying with the recommendation.
