3. The committee proceeded to consider Chapter 16 (Justice) of the 2006 Report of the Provincial Auditor (Volume 3). Mr. Deis of the Office of the Provincial Auditor provided an overview of the chapter.

The committee concurred with recommendation 16-1 made at page 378 of Chapter 16 (Justice) of the *2006 Report of the Provincial Auditor (Volume 3)* that the Department of Justice should secure and monitor access to information technology systems and data. The committee noted that the Department of Justice is making progress towards complying with the recommendation.
- 5. The committee concurred with recommendation 16-2 made at page 379 of Chapter 16 (Justice) of the *2006 Report of the Provincial Auditor (Volume 3)* that the Department of Justice should improve its human resource plan by:
 - Quantifying its human resource needs;
 - Providing details on the human resource gap between actual and required resources; and
 - Providing measurable indicators and targets.

The committee noted that the Department of Justice is making progress towards complying with the recommendation.

- 6. The committee concurred with recommendation 16-3 made at page 381 of Chapter 16 (Justice) of the 2006 Report of the Provincial Auditor (Volume 3) that the Public Guardian and Trustee of Saskatchewan should fix its payment system to reduce the risk of duplicate payments. The committee noted that the Public Guardian and Trustee of Saskatchewan is making progress towards complying with the recommendation.
- 7. The committee proceeded to consider Chapter 18 (Northern Affairs) of the *2006 Report of the Provincial Auditor (Volume 3)*. Mr. Ahmad of the Office of the Provincial Auditor provided an overview of the chapter.

The committee noted that the Department of Northern Affairs is making progress towards complying with the recommendation.

That the Standing Committee on Public Accounts authorize the attendance of the Chair, the Vice-Chair, one government member of the committee and one opposition member of the committee at the Twenty-eighth Annual Meeting of the Canadian Council of Public Accounts Committee to be held in Victoria, British Columbia, August 19th to 21st, 2007, and further that if the Chair or Vice-Chair cannot attend, they be authorized to designate another committee member to attend in their place.
