# 6. WESTANK INDUSTRIES LTD. (41)

The Committee agreed to call officials of Westank Industries Ltd./SEDCO as appropriate.

### 7. WESTERN DEVELOPMENT MUSEUM (42)

The Committee noted with satisfaction the steps that are being taken to rectify the problems identified by the Provincial Auditor.

8. The Committee requested the Provincial Auditor to report to the Committee on the effects of the proposed

amendments to the Provincial Auditor's Act introduced in the Assembly on September 21, 1987.

- 9. The Committee agreed to consider the remainder of the Provincial Auditor's Report at the next meeting followed by a hearing on Crown Management Board at 9:00 a.m. respecting the use of private sector auditors in crown corporations.
