- 9. The Committee requested information with respect to the travel and related expenses for Mr. D. Heron while an Associate Deputy Minister situated in Saskatoon, and including the cost of the Saskatoon office.
- 10. The Committee requested the Provincial Auditor to provide the Committee with the amount of the audit fee charged to each Crown Corporation for their 1985 year by the Office of the Provincial Auditor.
- 11. The Committee requested the Department to provide information regarding who directed that the investment be made of \$4 million in Pioneer Trust in January 1985.
- 12. The Department agreed to provide information as requested by the Committee regarding the background to January 1985 investments in Pioneer Trust.
