And the Chairman ruled that the prohibition against referring in debate or questions to matters that are before the courts is an established and well-understood principle in modern legislatures. Parliaments have voluntarily imposed restrictions on the member's right to free speech in order to prevent the possibility of such debate having a prejudicial effect on the rights of a citizen to a fair trial.

A corollary, though only recently expressed as part of the reason for the restriction, is to maintain the independence of the courts and judiciary from the legislative branch of government both in perception and reality. The application of the rule or the convention to matters that are before the courts is well documented in precedence in many jurisdictions. The convention is usually applied fairly strictly in criminal cases but somewhat less rigidly in civil cases.

I would point out that Erskine May's, 21st edition on page 378 indicates that:

Successive Speakers have exercised their discretion to allow matters to be discussed, on which (although they fall within the strict terms of the *sub judice* rule) they have considered that no substantial risk of prejudicing proceedings would arise.

The Chairman ruled that questions should not be answered as the matters covered in the line of questioning are *sub judice* and may well prejudice pending criminal court proceedings. The Chairman stated that the charges already laid, including charges relating to executive expenditures, relate to activities from January 1, 1988 to February 14, 1990, a period which covers the year under review by this Committee.
