That the Committee hold a briefing session on Thursday, December 12, 1991 and Tuesday, December 1 7, 1991, if necessary, for Members of the Committee on the role and mandate of the Committee, of the Provincial Auditor and of the Provincial Comptroller; and

That the Chairman, Vice-Chairman and Clerk of the Committee arrange an orientation seminar of one day for the Members of the Committee between January 1 and March 15, 1992, on the first day of the five-day intersessional meetings as agreed to by this Committee.
