Re: Reporting of Public Losses for the Health System

I have attached the report of Losses of Public Money at the Saskatchewan Health Authority (SHA), the Athabasca Health Authority (AHA), and the Saskatchewan Cancer Agency (SCA) from October 1, 2017 to December 31, 2017.

The report contains four new instances of losses of public money:

- A SCA employee at the Saskatoon Cancer Centre misappropriated between \$1,500 and \$3,750 in funds designated for patient financial assistance.
- The Community Health Services building in Lloydminster was broken into resulting in \$750 in damages and stolen property.
- A set of four winter tires valued at \$840 were stolen from the Riverside Health Complex in Turtleford.
- An ambulance employee's camper was broken into while working in Maidstone resulting in \$5,063 in SHA property and personal items stolen.
