The Chair: — Okay. Hello committee members, and thank you for joining us today. This is the Standing Committee on Private Bills, and I am the Chairman, Doug Steele. Today with us we have Ms. Vicki Mowat, Mr. Terry Dennis, Mr. Delbert Kirsch, and Mr. Joe Hargrave.

We're here today to examine the petitions for bills from three organizations: petitions for Bill No. 902, Mennonite Union Waisenamt; petition for private Bill No. 903, Collège Mathieu; and petition for private Bill No. 904, United Church of Canada. The first order of business is the consideration of a report on the petitioners' compliance with the rules. The Law Clerk and Parliamentary Counsel, Ken Ring, will provide his first report.

Mr. Ring: — Good morning, committee members. You have reports before you with respect to all three bills. They are all fully compliant with the rules required by the Assembly in order for the bills to proceed through the process.

The Chair: — Thank you, Mr. Ring. Are there any questions from the committee members? I would like to table the following report from the Law Clerk as PBC 3-29, Law Clerk and Parliamentary Counsel: Report on petitioner's compliance with the rules for petition for private Bill No. 902, dated November 23rd, 2021.

We will now deal with the second petition and have Mr. Ring provide his report on that on this petition.

Mr. Ring: — Bill 903 from the Collège Mathieu is also in full compliance with the rules in order for this bill to proceed through the process.

The Chair: — Thank you, Mr. Ring. Are there any questions from the committee members? I would like to table the following report from the Law Clerk as PBC 4-29, Law Clerk and Parliamentary Counsel: Report on the petitioner's compliance with the rules for petition for private Bill No. 903, dated November 23rd, 2021.

We will now deal with the third and final petition, and have Mr. Ring provide us with a report on this petition.

Mr. Ring: — I am pleased to report that Bill No. 904 for the United Church of Canada is also fully compliant with the rules as required by the Legislative Assembly in order for the bill to proceed forward.

The Chair: — Thank you, Mr. Ring. Are there any questions from the committee members? Seeing none, I would like to table the following report from the Law Clerk as PBC 5-29, Law Clerk and Parliamentary Counsel: Report on the petitioner's compliance with the rules for petition for private Bill No. 904, dated November 23rd, 2021.

We are done reviewing the petitions. I would like to ask a member to move the following motion.

Mr. Dennis: — I move:

That the Law Clerk and Parliamentary Counsel's report on the petitioners' compliance with rules for petitions for private Bill 902, private Bill 903, and private Bill 904 be accepted.

The Chair: — Carried. Okay. The last item of business is consideration of the committee's report. Are there any questions? Seeing none, I would like to ask a member to move the following motion.
