- (2) the timelines required under Rules 71-83 would need to be modified to enable consideration and passage of the Wheat Pool bill in this fall session.

That the Committee recommend to the Assembly that Rule 64 regarding the filing deadline for petitions be waived and that, pursuant to Rule 84, the timelines in Rules 71-83 be modified to enable the consideration and passage of the Saskatchewan Wheat Pool amending bill by December 18, 2002.
