

## SPECIAL COMMITTEE ON TRAFFIC SAFETY

## STEERING COMMITTEE FIRST REPORT

Your steering committee met on Wednesday, March 13, 2013 and Monday, March 25, 2013 to consider how to proceed with the following order of the Legislative Assembly:

That a Special Committee on Traffic Safety be appointed in accordance with Rule 150(1) of the Rules and Procedures of the Legislative Assembly of Saskatchewan to conduct an inquiry on matters related to:

Improving traffic safety and reducing fatalities by examining the dominant factors that cause traffic collisions in the province; impaired driving, distracted driving, excessive speed, intersection safety, and wildlife collisions as well as education and public awareness issues related to traffic safety; and,

That the said committee shall hold public hearings to receive representations from interested individuals and groups and report its recommendations to the Assembly by August 30, 2013; and further.

That Members Hickie, Wilson, Cox, Parent, Steinley, Chartier and Vermette be appointed to the said committee.

1. The committee's tentative schedule for public hearings is as follows (the schedule may change depending on the number of requests to appear before the committee):

May 21, 22, 2013 - Regina

May 23, 2013 – Swift Current

May 28, 2013 – Estevan

May 29, 2013 – Yorkton

- 2. Pelican Narrows may be added to the public hearings schedule based on the number of requests to appear before the committee.
- 3. The Steering Committee will meet on Monday, May 13, 2013 at 8:00 a.m. to consider all requests to appear before the committee and finalize the public hearing's locations, dates and times.
- 4. The Steering Committee will approve a list of stakeholders to be invited to make presentations to the committee.

- 5. Advertisements giving notice of the committee's proceedings will be placed twice in each Saskatchewan daily newspaper and once in each Saskatchewan weekly newspaper. In addition advertisements will be placed with Missinippi Radio. Further, no-cost advertising will be utilized as necessary.
- 6. The deadline for witnesses to request an appearance before the committee is 5 p.m. on Friday, May 10, 2013.
- 7. The deadline for written submissions is 5 p.m. on Thursday, June 6, 2013.
- 8. Each group or individual to appear before the committee will be given 25 minutes (15 minutes for presentation and 10 minutes for questions) in which to make their presentation, including time for questioning by the committee.
- 9. Pending approval for a leave of absence from the Legislative Assembly, the Chair and Deputy Chair will attend, on behalf of the committee, the  $5^{th}$  International Conference on Urban Traffic Safety on April 29 May 1, 2013 in Edmonton, Alberta.
